COMMUNITY SCHOLARSHIP APPLICATION INFORMATION

The Nucor Steel Texas Community Scholarship was established for the charitable and educational purpose of awarding scholarship grants to deserving young men and women. The awarding of scholarships helps to encourage individual, as well as community development.

Nucor and its affiliates are manufacturers of steel and steel products, with operating facilities in the United States, Canada and Mexico. Products produced include carbon and alloy steel – in bars, beams, sheet and plate; hollow structural section tubing; electrical conduit; steel racking; steel piling; steel joists and joist girders; steel deck; fabricated concrete reinforcing steel; cold finished steel; precision castings; steel fasteners; metal building systems; insulated metal panels; overhead doors; steel grating; and wire and wire mesh. Nucor, through The David J. Joseph Company and its affiliates, also brokers ferrous and nonferrous metals, pig iron and hot briquetted iron / direct reduced iron; supplies ferro-alloys; and processes ferrous and nonferrous scrap.

WHAT IS THE PURPOSE OF THIS SCHOLARSHIP?

The purpose of this scholarship is to help finance the undergraduate education of an eligible applicant.

WHO IS ELIGIBLE TO APPLY FOR THE NUCOR STEEL TEXAS COMMUNITY SCHOLARSHIP?

A person is eligible for the Nucor Steel Texas Community Scholarship if he or she meets the following requirements:

- Attends high school in one of the following Texas counties: Leon, Freestone, Limestone, Madison or Robertson; and continues to do so until the scholarship is awarded.
- Is currently a high school senior.
- Is not affiliated with Nucor by way of personal employment or employment of any member of their immediate family (parent, grandparent, sibling).
- Has a cumulative GPA of 3.0 or above.

WHO WILL MAKE THE SELECTIONS?

Applications for this scholarship will be reviewed by a scholarship selection committee comprised of Nucor Steel Texas employees from different jobs and areas of our facility.

HOW MUCH IS THE SCHOLARSHIP AWARD AMOUNT?

The award amount is a one-time payment of \$1,000 to the student for out-of-pocket education expenses. Each year the total number of scholarships awarded may vary, but it will be a minimum of ten (10). Scholarship payment requests must be received no later than December 1st of the year in which the scholarship is awarded.

WHAT CAN THE SCHOLARSHIP BE USED FOR?

Scholarship funds may be used toward the recipient's out-of-pocket undergraduate educational expenses and funds are paid directly to the student. Expenses include tuition, fees, books and materials, and room and board.

HOW CAN YOU APPLY FOR THE SCHOLARSHIP?

Complete the application and essay provided by your Guidance Counselor and submit along with a current high school transcript (includes grades through 7th semester/Fall of senior year) and (1) letter of recommendation from a teacher, coach, or school administrator to the Nucor Steel Texas Community Scholarship Committee on or before **March 16**.
